21/20 Apologies: Apologies were received from Cllr D Lewis and Cllr A Lewis.

22/20 Appointment of Chair

Members had been previously notified of the resignation of Cllr Long due to health reasons with immediate effect. There being no other nominations Members voted unanimously to elect Cllr TA Browne as Chair

23/20 Appointment of Vice Chair

There being no other nominations Members voted unanimously to elect Cllr Deakin as Vice Chair.

24/20 Councillor Vacancies

There are two Cllr vacancies which will be re advertised.

25/20 Requests for Dispensations

There were no requests for dispensations.

26/20 Declarations of Interest

Cllr Edgar declared an interest in item 32/20 planning application 3762N

27/20 Public participation

There were no members of the public in attendance.

28/20 Community Garden

Members were advised that due to there being a collapse of a crypt, access to the community garden was currently unavailable and very little work was able to be carried out until further notice.

31/20 Planning Decisions and applications

Planning Decisions

There were no new planning decisions reported.

Planning Withdrawals

There were no planning withdrawals to report.

Planning Applications:

20/3762N Residential development for 148 new build dwellings & associated works Land off Sydney Road, Crewe. Cllr Spruce provided a brief update advising that there were no material changes from that which had been previously presented and that the Parish Councils position remained unchanged with no objections.

South Cheshire Growth Village

Members were advised that a decision on the land off David Whitby Way had been deferred following concern over the schooling plan.

32/20 Reports from Councillors

Councillors continue to express concerns on the ongoing issues on the B5077. There were no other matters reported.

33/20 Clerks report

The Clerk had no additional items to report

34/20 Report from Cheshire East Councillor

Cllr Edgar reported that he had been removed from the A500 Committee.

In spite of that Cllr Edgar reported on a range of statistical data, on traffic flow, both current and predicted, where diversions, passing places and pinch points are likely, with potential banning of HGV's along the diversion routes.

A liaison group is being set up which may include local Police but as yet no traffic management scheme in place Cllr Edgar further advised that the Aldi management had been found to comply with the recent query over landscaping and confirmed the Aldi application to increase the car parking capacity which was likely to further improve the landscaping. Cllr Browne that she would be prepared to act as liaison if necessary. Cllr Edgar advised that he was likely to be on the upcoming Boundary working group.
